#### Announces One (1) Researcher Position

## One (1) Researcher B (Principal Investigator) or C (Assistant Researcher) Grade in the field of "Molecular Biology and Biotechnology"

Candidates for this position should

- a) Hold a PhD degree, and have completed postgraduate studies relevant to the subject of the Announcement
- b) Have the minimum qualifications specified in Article 18 of Law 4310/2014 as amended and currently in force:
  - for level B (Principal Investigator), the researcher must have a documented ability to organize and manage research and technological development programmes, to coordinate and direct research and technological development in the individual projects of the research and technological development programme, to seek and attract financial resources from external sources to finance the activities of the institute or center and to promote innovative ideas in science and technology. It is also required to have original publications in scientific and technical journals of international impact or to hold international patents and to have contributed to the advancement of science and technology and their applications and to have been recognized by other researchers for his/her contribution to the advancement of science and technology.
  - for level C (Assistant Researcher), the researcher must have three years' experience in carrying out research work, the ability to design and implement RTD projects, to seek and attract financial resources from external sources for the funding of the institute or research center.

c) Be a Greek citizen or citizen of an EU Member State. For citizens of EU Member States adequate knowledge of the Greek language is required, as demonstrated by a Certificate of Attainment in Greek from a recognized Language Centre or by an equivalent certificate issued by the School of Modern Greek Language of the Aristotle University of Thessaloniki, granted at the request of the candidate.

- d) Should not have a criminal record
- e) Male candidates must have fulfilled their military service obligations or have been legally discharged from them.

#### Documents to be submitted include:

- 1. Application form (see Appendix 1)
- 2. Detailed curriculum vitae according to the guidelines of the European Union (in Greek and English)
- 3. Detailed statement on their scientific and research work, including a summary of their research interests
- 4. A photocopy of both sides of the ID card (for citizens of EU member states, a certificate from the respective authority of the state of the candidate's citizenship)
- 5. Copies of diplomas proving the required qualifications
  - Plain and legible copies if issued by a public body, or
  - Simple and legible copies of private documents, if they have been originally certified by a lawyer, as well as clear photocopies of the originals of those private documents that are certified by the services and institutions that fall under the regulation of Law 4250/2014, or
  - Copies of all degrees, domestic or foreign. Certified copies of all degrees should be submitted in case
    of appointment. For degrees awarded abroad, candidates are required to submit a certificate of
    approval from the Hellenic Academic Recognition Information Center (Hellenic NARIC), or at least a
    submitted application for approval, when submitting the application or alternatively upon
    appointment.
- 7. Statutory Declaration of Law 1599/1986 (only males) that at the time of their appointment they have fulfilled their military obligations or have been legally exempted from them
- 8. Statutory Declaration of Law 1599/1986 that the candidate has the typical qualifications
